## Extensive Centralized Management

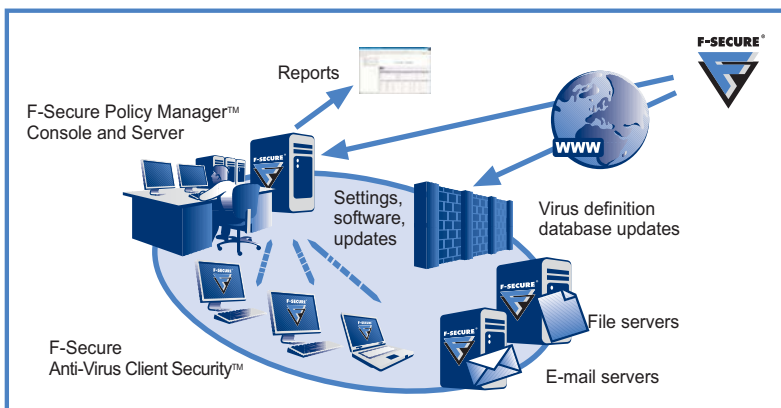
